#### Application/Limitation

The scope of this approval is limited to use of the system for:

- 1. Two-way voice communication onboard small vessels not requiring more than 3 extensions and not requiring simultaneous calls between substations.
- 2. PA system onboard small cargo vessels. The audibility of the PA system shall be tested for each installation.
- The system is also tested based on the manufacturer's definition of Talk Back system and found to be in accordance with the stated functionality in the manuals. The system cannot be used for Hands-free two-way voice communication system as required by DNVGL Rules

### Marking of product

The name and contact address of the manufacturer and type designation of the product shall be affixed to the equipment in a clearly visible location. In addition the equipment shall be marked with serial number, safe distance to magnetic compass, power consumption and/or supply voltage and reference to the Type Approval certificate number.

#### Periodical assessment
